# 2. Watershed Planning 101

Tessa gave a brief presentation covering the basics of watershed planning including the Clean Water Act, watershed plans, and local community involvement. *The Watershed Planning Guidebook for Kentucky Communities* is a reference material for learning more about watershed planning and for writing a watershed plan. This is the guide the Harrods Creek team will use to write the Harrods Creek Watershed plan. Also, there is a "Watershed Basics" section that reviews the basics of watershed planning and water quality issues.

One of the main overall goals of watershed planning is community involvement. While water quality and habitat improvement are central, local interest and participation are what makes a plan ultimately successful. This does not mean that everyone always agrees, but it does mean that everyone is welcome, and all voices can be heard. Writing the watershed plan itself will be a large component of the project, but education and outreach activities are essential as well. This can include volunteer speaking engagements to the community, tabling at events, recreational outings like paddles and hikes, farm tours, agricultural water quality plan workshops, Clean Water Act trainings, and many other things that the watershed team is interested in pursuing.

#### 3. Chapter 1 and Project Goals

Chapter 1 of the Harrods Creek Watershed Plan will outline the initial goals and concerns of the watershed team. Like all watershed plan chapters, Chapter 1 will need reviewing by the watershed team for accuracy and readability. The watershed plan should be understandable to everyone. Tessa hopes to bring a draft of Chapter 1 to the next meeting.

It will also include a list of potential stakeholders – people who may be interested or impacted by the project. Watershed planning is iterative, so these lists may be revised and added to as the process progresses.
