THE KENTUCKY AQUATIC RESOURCES FUND (KARF) ACCEPTS FUNDS FROM (AUTHORIZED) DEVELOPMENT PROJECTS THAT HAVE CAUSED NEGATIVE IMPACTS TO AQUATIC SPECIES AND WATERWAYS IN THE STATE. THE FUNDS ARE USED TO AID IN THE CONSERVATION AND RECOVERY OF WATERWAYS AND AQUATIC SPECIES BY MITIGATING THE EFFECTS FROM THESE PROJECTS IN OTHER APPROVED SITES. KARF FUNDS HAVE PURCHASED LAND FOR CONSERVATION, FUNDED STREAM MONITORING AND RESTORATION, ADVANCED THE RESEARCH ON FISH AND MUSSEL SPECIES, AND FUNDED THE BREEDING AND RELEASE OF THREATENED AND ENDANGERED SPECIES.
