**The Kentucky Aquatic Resources Fund (KARF) accepts funds from (authorized) development projects that have caused negative impacts to aquatic species and waterways in the state. The funds are used to aid in the conservation and recovery of waterways and aquatic species by mitigating the effects from these projects in other approved sites. KARF also accepts federal grant funds. KARF funds have purchased land for conservation, funded stream monitoring and restoration, advanced the research on fish and mussel species, and funded the breeding and release of threatened and endangered species.**

**WATERSHED PLANNING - assist communities and watershed groups in watershed planning - KWA works with communities and local groups to facilitate watershed planning and management. The work includes building local alliances, writing and implementing watershed plans, and organizing education and outreach events and programs. In 2017, we worked closely with five communities on watershed issues, covering over 300 square miles and impacting more than a million people. The watersheds and their issues are diverse. From the Red River watershed, which includes some of the best water quality in the state, to rural areas such as Bacon Creek and Harrods Creek, to intensely urban Beargrass Creek.**

**CWA ENFORCEMENT - Improve implementation & enforcement of the Clean Water Act in Kentucky - we help to protect water quality, save wetlands and floodplains and assist in cleaning up polluted waters. We work with state and federal agencies to improve clean water act laws and regulations; improve discharge permits so that fewer pollutants are discharged into our waterways; and to halt or minimize wetlands fill and destruction. When state or federal agencies are lax in enforcement of water regulations or the adoption of protective criteria, we urge them to do their jobs with comments and public engagement or litigation if necessary.**
