Watershed Management Program - this program focuses our effort on specific waterways in a partnership with local stakeholders as well as agencies such as the Kentucky Division of Water and US Forest Service. The goal of this work is to restore and protect waterways that have become polluted (impaired) so that current and future generations can fully use and enjoy all the waterways of Kentucky. KWA provides expertise in watershed planning and implementation to local waterways groups, as well as technical and financial support to help them be more effective. In 2019, our watershed program continued to work on projects in Red River, Salt River, Green River, Beargrass Creek, and Harrods Creek. We helped to form a new watershed group in the Rockcastle River watershed as well.

Kentucky Aquatic Resources Fund (KARF) is a funding mechanism for protection and restoration of aquatic wildlife in Kentucky. The funds are held and managed by KWA as defined in a Memorandum of Agreement with the US Fish & Wildlife Service. Through this cooperative effort, KWA and US Fish & Wildlife have funded dozens of projects over the past 12 years. These projects have restored streams and wetlands, researched habitat needs of mussels and fish, re-established endangered species to former habitat, and removed a dam on the Green River. Funding for this work comes from US Fish & Wildlife programs and mitigation payments from developers and agencies that have impacted aquatic resources. In 2019, KARF funded over \$900,000 of work to protect and restore aquatic wildlife habitat in Kentucky.

6.0 MANAGEMENT AND MONITORING REQUIREMENTS

6.1 DESCRIPTIONS OF LONG-TERM MANAGEMENT TASKS

6.1.1 SIGNAGE

Prescribed signage will generally be placed every 300 feet along the easement boundary and/or at easement corners that provides for 300 feet of marker siting in two directions. KWA will ensure signage is visible, legible, not damaged, or missing. If missing, or damaged KWA will replace the signage.

6.1.2 PERIODIC INSPECTIONS

Part XIII Supplemental Information (continued)

KWA will conduct a pedestrian survey of the project and accesses annually to ensure the easement agreement is upheld and appropriate signage is installed. KWA will provide a summary report to the USACE every year unless significant infractions occur that require notice of violation be given in writing to the grantor.

6.1.3 LANDOWNER COORDINATION

KWA must notify the Landowners by letter if KWA personnel will be accessing their property. If the individuals present on the behalf of the USACE or the Commonwealth agencies wish to access the project they must coordinate with KWA and allow KWA to provide the landowner with advance notice before entering the property.

6.1.4 EASEMENT ENFORCEMENT

KWA will be responsible for ensuring that the landowners adhere to the restrictions of the easement (Appendix M). If any infractions occur that cannot be remedied according to the terms of the conservation easement or if the landowners refuse to adhere to the conservation easement then KWA will legally enforce the easement.

Conservation easements represent restrictions on the use, subdivision and/or development of certain parcels of land. Conservation easements received or purchased bear no future benefit to KWA and are therefore recognized as program expense in the year they are acquired.

KWA accepts cash as a fiscal agent for the Kentucky Aquatic Resource Fund and agrees to disburse those assets to designated beneficiaries. KWA has no discretion on the assets held. Assets held by KWA for these donors are classified as fiscal agent payable on the statement of financial position.
